Gravel Crushing Tender (75,000 cubic yards) RM499-2025-05 - Synopsis

Tenders are invited by the R.M. of Mervin No. 499 for the crushing of approximately 75,000 cubic yards of gravel as follows:

NW 9-51-19-W3 (Cormack Pit)

- 25,000 cubic yards of 1-inch type traffic gravel as per specifications listed in Schedule "A" of the Instruction to Bidders document.

NW 31-51-19-W3 (Johnson Pit A)

- 50,000 cubic yards of 1-inch type traffic gravel as per specifications listed in Schedule "A" of the Instruction to Bidders document.

Gravel is to be crushed in the Spring of 2026, and completed by June 30, 2026. Gravel will be stockpiled on site. The contractor must crush the product from the area of the pit as shown in the attached picture. Any crushing outside the specified area must be approved by the Municipal Foreman.

Crusher must have the capability to crush a minimum of 24-inch sized rock. Bidders must list the jaw size of the crusher they will be using with the list of equipment on the bid document.

Potential bidders must familiarize themselves with the extent of the work required, make themselves thoroughly acquainted with all the requirements of this tender, and obtain all information necessary for the preparation of the bid including the location of the pits. It is recommended that bidders view the pits before tending.

The R.M. will pay per cubic yard for finished product crushed to the required specifications and as measured by the R.M.'s engineer. The payment per yard is calculated solely on the product that is crushed to the R.M.'s specifications and piled for the R.M. The payment per yard for screened/reject gravel will be paid separately at the bid price for the screened/reject gravel and as measured by the engineer.

A Bid Bond in the amount of 5% of the contract is to be provided with the tender.

A Performance Bond in the amount of \$20,000.00 is required within 21 days the tender being awarded. The full amount will be returned if project is completed by the specified date.

Payment will be made within 30 days of the completion of the final measurement of the piles.

Saskatchewan Worker's Compensation account number and the appropriate clearance letter must be included in the tender package.

Tenders must be submitted no later than 4:30 p.m. CST on November 6, 2025.

1. Time and Place

1.1 Tenders will be submitted to the Rural Municipality of Mervin No. 499 by November 6, 2025 at 4:30 p.m. CST. Tenders may be submitted by the following means:

2. Tender Acceptance

- 2.1 The Municipality reserves the right to refuse to accept any or all tenders, and the lowest tender will not necessarily be accepted.
- 2.2 Without limiting the generality of the foregoing, any tender may be rejected which is incomplete, obscure or irregular.
- 2.3 The Municipality reserves the right to cancel the acceptance of any tender at any time before the execution of the contract by all parties without any liability against the Municipality.
- 2.4 Tenders received after the time and date specified in clause one (1) will not be considered.

3. Validity of Tenders

3.1 A bidder may, without prejudice to them self, withdraw a tender at any time up to two (2) hours of the time specified in clause one (1).

The tenders received will be valid for a period of fifteen (15) days from the date of the

opening of the tender.

4. Tender Limitations

- 4.1 Oral and telephone tenders will not be considered.
- 4.2 Oral and telephone modifications to submitted tenders will not be considered.

 Modifications will only be accepted in writing by the means noted in clause one (1).

5. Examination

5.1 Potential bidders must familiarize themselves with the extent of the work required, make themselves thoroughly acquainted with all the requirements of this tender, and obtain all information necessary for the preparation of the bid including the location of the pit where the gravel is to be crushed.

6. Tender submissions

- 6.1 All tenders shall include the following information:
 - a) Unit price per crushed cubic yard of 1" Traffic Road Gravel as per specifications in attached Schedule "A";
 - b) Unit price per cubic yard of screened off/reject gravel;
 - c) Price for any required stripping of the work area
 - d) A copy of an up to date Letter of Good Standing with the Saskatchewan Workers Compensation Board;
 - e) A list of equipment/machinery relevant to the completion of the Gravel Crush along with a copy of valid liability insurance;
 - f) Start date;
 - g) Bid Bond in the amount of 5% of the contract to be provided with the tender;
 - h) Performance Bond in the amount of \$20,000.00 within twenty-one (21) days of awarding the tender. The full amount will be returned if project is complete by the specified date.

7. Labour, Materials & Equipment

- 7.1 The successful bidder shall supply all supervision, labour, materials, equipment, tools and all other things necessary for the complete supply of the work as indicated or intended by the specifications which form part of this document
- 7.2 The unit price shall include the supply of all supervision, labour, materials, equipment, tools and all other things necessary for the complete supply of the work
- 7.3 The R.M. will pay per cubic yard for finished product crushed to the required specifications and as measured by the R.M.'s engineer. The payment per yard is calculated solely on the product that is crushed to the R.M.'s specifications and piled for the R.M. The payment per yard for screened/reject gravel will be paid separately at the bid price for the screened/reject gravel and as measured by the engineer.
- 7.4 The contractor must crush the product from the area or areas of the pits as specified. Any crushing outside the specified area must be approved by the Municipal Foreman.

8. Commencement and Completion of Work

8.1 Time will be of the essence of the Contract made with the successful bidder. The Contractor will be required to comply strictly with the dates specified, subject to the terms of the contract.

9. Site Inspection

9.1 The successful bidder will be required to meet with the Municipality on site prior to commencement of the work.

10. Goods and Services Tax

10.1 The tender unit price shall not include Goods and Services Tax.


