REQUEST FOR BIDS

Scrap Metal Removal & Site Clean-Up

RM of Mervin Transfer Site SE 34-52-20-W3

The Rural Municipality of Mervin No. 499 (RM) is requesting bids from qualified contractors for the removal of scrap metal and complete clean-up of the metal pile at the transfer site.

The site currently contains a large accumulation of mixed scrap metal, appliances, structural steel, and miscellaneous debris, as illustrated in the attached photos.

1. SCOPE OF WORK

The successful bidder will be responsible for:

- Removal of all scrap metal, including but not limited to, appliances, structural and sheet metal, piping, culverts, and tanks, and miscellaneous ferrous and non-ferrous materials.
- Processing and hauling of materials off-site at the contractor's expense.
- Complete clean-up of the area, including but not limited to, removal of loose debris associated with the metal pile, separation and proper disposal of non-metal waste (if encountered), and leave the site in a clean, level, and safe condition.
- Environmental compliance, including but not limited to, proper handling of any hazardous components (e.g., refrigerants, oils), and adherence to all Saskatchewan environmental regulations.

2. SITE CONDITIONS

- The scrap pile is substantial in size and includes mixed and compacted materials.
- Access is available for heavy equipment.
- Spring conditions (snow, mud) and weather may affect operations.
- Bidders are encouraged to visit the site prior to submitting a bid.

3. BID SUBMISSION REQUIREMENTS

Bids must include:

- Lump sum (clearly stated).
- Description of approach and equipment to be used.
- Estimated timeline for completion.
- Proof of Liability Insurance coverage and SK WCB Clearance.
- References for similar work.

Completion Deadline: August 15, 2026

5. TERMS & CONDITIONS

Contractor assumes responsibility for all labour, equipment, fuel, and transportation. Contractor is responsible for site safety during operations. Any damage to RM property must be repaired at the contractor's expense. All materials removed become the property of the contractor unless otherwise specified.
