

BYLAW NO. 2022-02

A BYLAW OF THE RURAL MUNICIPALITY OF MERVIN NO. 499 FOR THE ORGANIZED HAMLET OF EVERGREEN ACRES TO FIX THE RATES TO BE CHARGED FOR THE USAGE OF WATER AND SEWER.

THE COUNCIL of the Rural Municipality of Mervin No. 499, in the Province of Saskatchewan, enacts as follows:

1. All persons desiring to be supplied with water from the Hamlet's water supply system and access the Hamlet's sewer system shall make application to the officials of the Municipality as set out in Schedule "A" as attached hereto.
2. The charges to be paid by the water consumer whose water service has been turned on and has access to sewer services shall be those set out in Schedule "B" attached; provided, however, that the minimum shall be payable in every case whether or not any water is consumed or sewer lines used.
3. Accounts for water and sewer service shall cover a period of twelve successive months, unless otherwise specified on Schedule "B". Accounts shall be paid within a period of thirty days from the date on which such accounts are rendered. If an account is not paid within the period of thirty days, the water and sewer services may be cut off. When the water and sewer services are cut off, it shall not be turned on until all arrears have been paid, together with a fee of **\$50.00** to cover the expenses of turning off the services and turning it on again; provided that if it is required to turn on the water service outside the employees' regular working hours, the fee shall be \$150.00 *for reconnection*.
4. Subject to Section 369(1)(a) and (b) of the Municipalities Act, the Administrator may add any outstanding accounts for water service to the parcel of land that the services were provided to.
5. To repeal Bylaw 2008-18 and 2009-12.

THE rates, charges, tolls or rents contained in this bylaw shall come into force and take effect on the day of approval being issued by the Local Government Committee.





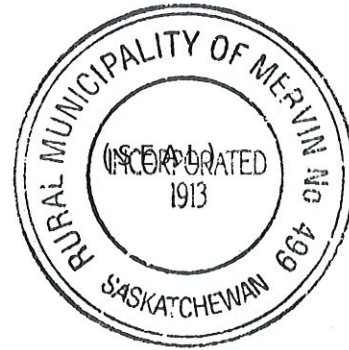
