

BYLAW NO. 2026-07

A BYLAW OF THE RURAL MUNICIPALITY OF MERVIN NO. 499 FOR THE ORGANIZED HAMLET OF LIVELONG TO FIX THE RATES TO BE CHARGED FOR THE USE AND CONSUMPTION OF WATER AND FOR THE USE OF SEWER

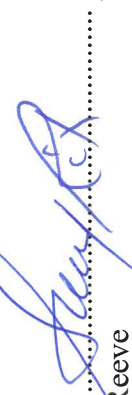
The Council of the Rural Municipality of Mervin No. 499, in the Province of Saskatchewan, enacts as follows:

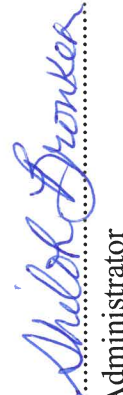
1. All persons desiring to be supplied with water from the Hamlet water supply system and sewer services shall make application to the officials of the Municipality. Each application shall be accompanied by a fee of \$25.00.
2. The charges to be paid by water consumers whose water service has been turned on shall be those set out in Schedule "A", attached hereto and forming part of this bylaw.
3. Accounts for water service and/or sewer service shall cover a period of three (3) months unless otherwise specified and shall be rendered on or before the first day of the month following such a period. Accounts shall be paid within ninety (90) days of invoice date. If the account is not paid within ninety (90) days, the water service may be disconnected. If water service is disconnected, it will not be restored until all arrears have been paid, together with a \$100.00 disconnect/reconnect fee. This additional fee will cover the costs of turning the water off and turning it on again.
4. A service charge of two percent (2%) shall be charged on all accounts that fall into arrears.
5. Subject to Section 369(1)(a) and (b) of *The Municipalities Act*, the Administrator may add any outstanding accounts for water service and/or sewer service to the taxes on the parcel of land that the services were provided to.
6. Bylaw 2020-03 is hereby repealed.
7. The rates, charges, tolls, or rents contained in this bylaw shall come into force and take effect on the day of approval being issued by the Local Government Committee or January 1, 2027, whichever is later.

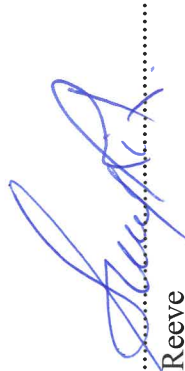


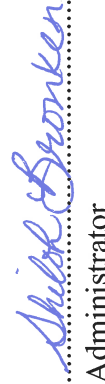

Year 1 (Effective Date)	\$303.50
Year 2	\$323.50
Year 3	\$343.50
Year 4	\$363.50
Year 5	\$383.50

Each annual rate increase shall take effect on January 1 of each successive year following the initial implementation date, unless otherwise specified by Council.
