# 5. **HAMLET BOARD REPORT** - Presented by Len Chmelyk

#### **DISCUSSION**

Chairman Len Chmelyk said the Hamlet Board met many times over the summer – Numerous phone calls, e-mails and texts
Speed bumps were installed in June
Signs regarding dogs were put up

## 911 DISASTER SERVICES

Fire, medical, 911 disaster procedures – Pat and Rod Sellers as well as Mark and Dorothy Schmeltzer and Teresa Popowicz offered their cabins, for protection in the event of a disaster.

Rod Seller and Teresa Popowicz volunteered to work with Len Chmelyk on an Emergency Response Plan.

Evelyn Bloom mentioned that the RM has a Procedure Manual in place.

**VANDALISM:**

# 6. <u>UNFINISHED BUSINESS</u>

## PROPERTY ID

Brad Gilbert said there are presently five different road signs in CBSB. These include West View, Lake Shore, Lake View, Willow Bay and Funk Drive.

CABIN IDENTIFICATION NUMBER: Each lot has a number.

We have budgeted for this. The RM bylaw is a five inch number. We will work with the RM to get a final determination of this. When we get a final

determination, Brad will present a rebid. When finalized, Brad will supply everyone with the proper numbers for their lot (lots).

At this time, we will give a copy of Bylaw #2014-02 and suggestions on how to mount the signs, to hamlet property owners.

Evelyn Bloom mentioned that these regulations are coming down from the Provincial Level.

The Hamlet will be paying for these signs. It will be of no cost to the cottage owner. The reason for this is that we have uniformity and they will all look the same.

<u>PUBLIC BEACH SHELTER</u>: – BRAD GILBERT reported that we have a fellow willing to do the work for us. The 12 x 24 shelter will be pressure treated wood with a metal roof, at a cost of \$3,500.00, labor included. This will be built close to the outhouses.

<u>WILLOW BAY</u>: - MARK SCHMELTZER commented on getting the clay off of Keith Young Youngblood's property for the Willow Bay road. Thanks to Keith for helping us out with that.

We finally have the mess cleaned up from the roadway.

We will be getting gravel on the road when it is dry enough.

This completes the projects.

<u>SPEED BUMPS</u> – LEN CHEMLYK addressed Speed Bumps to slow down traffic. We will put them up again this year with an additional one on Lakeshore Drive. Two will be installed in Willow Bay, as well as speed limit signage. They will be maintained to proper standard.

#### **#7 NEW BUSINESS**

TRAILER BYLAW: - LEN CHEMLYK stated that casual trailer parking became permanent parking. It became a very dangerous situation.

Last year, a regulation was made that there was to be no parking on roadways. The RM made it an enforceable bylaw. Thanks to Evelyn Bloom and the RM of Mervin, there is a \$2,000 fine for illegal parking now.

Hamlet will post signs regarding same.

MARK SCHMELTZER - said that trailers must be setback 20 feet from property lines, the same as a cabin. This is an RM bylaw.

<u>PUB</u> - The Hamlet has budgeted another \$5,000.00 to the Public Utility Board this year. This has been included and approved in the budget.

RAY SWAZEY – It is posted, by the bathrooms and boat launch, that there are to be no quads or motor bikes on the beach area.

Hamlet Board will see that it is enforced.

EVELYN BLOOM - Stated that the grid is done. The Hamlet Board will be attending a Council meeting to discuss this matter. JOHN MORRISON has had a lot of experience with roads. He will support the board in meeting with the RM regarding this.
