Paths at the end of streets to waterfront: Brad Caplan motioned to put 1" round rock on all pathways to help control runoff. Seconded by Trent Gatzke. Motion carried.

RAC road speed bumps: They have been purchased. Harry Rempel will organize to get them installed.

Burn pile and area: When persons are putting their name in for a task please be clear if you are donateing your time or expect compensation.

New Business Discussion:

Thank yous: To Bernie Luken and Kelly Knibbs for their time and efforts on the water/sewer system. To Denise Leptich for the procurement of the new playground and Rob Kohuch, along with everyone who helped, for the setup of the new playground.

Overview of Budget: Shawn Roy will review the general ledger accounts and accounts paid files. A motion was tabeled to reduce the water bill rate from \$1,100 to \$800.

Septic pump out: Residents are to contact a service provider of their choice. Confirm first that the service provider will bill to the RM/Hamlet.

Naming of the main road: Rob Kohuch motioned that the name be Evergreen Acres Road. Seconded by Denise Leptich. Motion Carried.

Golf Course Fees: To remain at \$50 per family.

Burn pile remains: Board to look into if the RM can haul away remains from burning.
