Old Business

<u>Hamlet Garage</u> – a 24x26 garage has been purchased for \$5000.00, it is located at Golden Sands and will have to be moved, cement pad will have to be poured, etc location is being changed, original location was next to Don & Peggy Roberts, but it will be located along Erica Road just behind the new trees that were planted behind the entrance sign, less facilities to deal with and no trees to be removed. Discussion took place as to whether both power and gas were going to be installed but no final decision was made, Hamlet board to pursue

<u>Fire Fighting Pump</u> – a trailer was purchased for \$300.00 and is currently being retrofitted, pump will be installed on trailer. Bev mentioned that Don Sideroff has made the old fire wagon ready by to use.

<u>Boat Launch</u> – repairs were done in the fall of 2018 at a cost of \$6153.69 and boat launch is back to the way it was, slabs are moving apart. Wayne Cook and Gord Rohs have fixed it and it is useable

<u>Gravelling & Grading</u> – all of Parkland will be graded, Bev Sideroff mentioned that there needs to be gravel spread on road in front/beside boat launch access. Gord to contact RM for gravel

<u>Motion was made by Bev Sideroff</u> – to purchase a new "Parkland Beach" entrance sign, the one at the corner of Aspen and Erica Roads. Bev will research and have information to present at the 2020 Annual General Meeting.

<u>Street signs in the Hamlet</u> – it has come to our attention that our signs and what is reflected on the RM maps are incorrect, specifically the map reflects Tyson Road however our sign says Spruce Lane. Google comes up as Spruce Lane. Discussed that for 911 reasons all signs need to be correct. The board members will do a drive thru the Hamlet and verify our signs with that of the RM.

Term is up for Roxanne Bernier, Gord opened the floor for nominations. Alex Opperman nominated Roxanne Bernier for another term, she declined. Gwen Lavallee nominated Sandra deMontarnal she declined.
