- a. Roads Areas in the Hamlet were identified and submitted to the RM. Darryl made a motion to use the previous supplier for calcium chloride. Motion passed.
- b. Waste management In doing comparison with WYRA and Loras it was noted that using 5 bins from Loras being dumped once per week would be a big cost savings. Motion made by Kyle that we trial the WYRA bins if we could wave the 3-year commitment. ACTION: Darryl to contact WYRA regarding the bins and contract.

8. Unfinished Business

- a. Washrooms update Kyle had sent the plans to Paige for where the washroom would be located and will be sending the map to Sask Power.
- b. Wake Zone Buoys Rhonda made a motion that Kyle pick the buoys up from the RM office next Friday.
- c. Dock extensions update Motion was made by Rhonda to purchase a dock extension with wheels (deep leg) and a new leg for the North beach dock. ACTION: Rhonda will talk to Adam to see if he is comfortable with ordering these from Western Boat Lift or if she needs to.

- d. AGM preparation Agenda items were discussed, and a motion was made by Rhonda to adopt the agenda as prepared and post the agenda to the website ahead of the meeting. Motion passed. **ACTION:** Darryl will check with the RM to see if they want to be a part of the description of services provided along side the Resort Village of Turtle View.
- e. Resort Village of Turtle View, discussion points
 - i. Water Plant Discussions will take place at a meeting on May 5th, 2024 with the Resort Village of Turtle View, SSVB Hamlet Board and the SSVB Utility Board.

Rhonda made a motion that we present the cost at the AGM in response to the letter the Hamlet Board received proposing purchase of that lot and one other lot. Motion passed.
- c. Election Policy revision Darryl made a motion to make the revisions to the portion that speaks to who can vote. Motion passed.
- d. Corrections required on SSVB Newsletter Kyle made a motion to revise the information in the newsletter regarding surplus information provided on Resort Village of Turtle View. Motion passed.
