#### 4. New Business:

- a. Maintenance team issues
  - i. Natasha was the board contact with the maintenance team. It was felt that there was too much interaction between Natasha and the team, one member in particular.   - ii. John Smith to fix inner roads, example: antler road. He's just waiting on Mitchell's to deliver gravel
- c. Signage
