1. Call to order at 4:30
2. Addition made to the agenda, Rhonda approved the agenda as modified.
3. Darrell approved the September 27, 2025 minutes.
4. Delegations - None
5. Communications
 - a. Request for maintenance to make a skating rink – Rhonda made a motion that we not hire maintenance to make a skating rink in the winter and respond to the correspondence that is not the responsibility of the Hamlet Board. Carried **ACTION:** Rhonda will respond to the correspondence.
 - b. RM of Mervin 2025 Semi-annual Hamlet Board meeting October 22nd, 2025 – everyone received their correspondence, was able to read through it and sign their declaration forms.
6. Standing agenda items
 - a. Roads – The roads have been plowed this winter 4 to 5 times. Our contracted service has been doing a great job.
 - b. Waste management – Things have been going well this winter except for Christmas break. Next year it may be beneficial to have all 5 bins unlocked throughout the Christmas break.
7. Board member forum
 - a. Maintenance contract for 2026 – While Adam has signed our contract for the 2026 season, he will have to sign the RM's contract. **ACTION:** Rhonda will get a contract from the RM for Adam to sign.
8. Unfinished business
 - a. Playground washroom – Kyle has gotten a price to install a septic tank and will continue to search for an appropriate structure. **ACTION:** Kyle will continue to look for a washroom structure and price it out.
 - b. Utility Board Update – No update today. The MOU is in place between the Utility Board and the RM of Mervin to cover future costs.
 - c. 5-year Capital Plan – Board members should review and bring any suggestion for changes to the next meeting. It will be easier to update once we have the financial report from the RM.
 - d. South beach parking – Rhonda has contacted Paige to see if she will help with the development of the public reserve area for golf cart and ATV parking. There should not be a need to remove many trees to accommodate parking. Rhonda will continue working with the RM to complete in the spring.

- e. Booking time with RM of Mervin Fire Department in the spring – this will have to be done once the new board is in place in the spring.
- 9. New business
 - a. Community Court Update, policies, and noise abatement – Darrell has been exploring options for better noise abatement. Some of the options look very costly. Another option would be to cut off pickleball play at 6 or 7 PM in the evening at a much lower cost. We will present both options at the AGM. **ACTION:** Rhonda will work on draft policies for the pickleball court.
 - b. Cul-de-sac on Kenderdine – There was a request this winter to do snow removal in the small cul-de-sac on Kenderdine North. For future safe snow removal that cul-de-sac will need to have a formal gravelled road put though the area. Kyle made a motion to put this as part of the drainage project. Carried. **ACTION:** Kyle add this to the drainage project and will continue to work with the RM for completion of the project.
 - c. Swimming lessons – Rhonda made a motion that we accept Erin Kobelka to teach swimming lessons again this year at Sunset View Beach. Carried. **ACTION:** Rhonda will inform Erin and find out what information is needed to submit to the RM of Mervin.
 - d. Movement of garbage bins to Starlight lane – Rhonda made a motion that we move the bins from the area they are currently in due to odor that surrounding residents have to endure. Carried. **ACTION:** Darrell will get a couple of contractor quotes to prepare the area on Starlight Lane for the garbage bins.
 - e. Contract services – **ACTION:** Rhonda will ask the RM if maintenance would still be covered by the RM contract for as needed jobs in the winter season.
