- 5. Old Business
  - a. Review of 2017 Expenditures
    - i. No comments provided. Report accepted as presented.
- 6. New Business
  - a. Berm Repairs
    - i. Suggestion to leave the berm as it is
    - ii. Lake side is good
    - iii. Some clean up on the green space side is required
    - iv. There was an engineer report and there is a cost to fix the berm however it is very expensive.
    - v. Possible to get a small hoe in on the north side to push the rocks back the cost would be an hourly rate and it would not be much
    - vi. When the north end dries up some clean up can be done there too as much possible. There could be some swamp mats used but they are costly
    - vii. Several people don't want to invest a lot of cost into repairs
    - viii. It was suggested that we could put a road in on the north side
    - ix. There is concern that if a road go in there would be no room for proper drainage and the electric pumps may be compromised

- x. Discussion on what would happen if the water breaks through the berm comments that the berm is now higher in places. It cold potentially breakthrough in other areas. Investigate the integrity of the berm was suggested and if there is an issue then reinforce as necessary
- xi. Suggestion that it is possible to plant a few more trees to help support the berm
- xii. The berm is narrower and some concern expressed that waves can chew away at the berm faster
- xiii. Question about the number of sandbags in case water comes over, there are some.
- xiv. The berm is not there to stop the lake to come in. If the water comes in we need to react effectively with sandbags, etc. Suggested to have a surface (road) or plan to deal with water quickly if such an incident happens. The berm just delays the water flooding the area so people can respond to stop the damage.
- xv. The north side is way to soft for any equipment as it will sink
- xvi. Suggested there should be 2 steps a) that the board get an estimate for the cost to inspect the integrity of the berm and b) that the board consult with the RM to see if they will support it financially.
- xvii. There is no dam to control the water levels like other lakes, beaver dams, culverts, etc. That cause problems but the RM has not responded to any of the requests to deal with water flow issues and they continue to not be receptive to suggestions or problem solving.
- xviii. Requested that people don't touch the berm as there are restrictions on what can be done. Nothing can be done on the water side.
- xix. Dead, dangerous, damaged trees can be taken down on the green space side.
- xx. You can clean up the dirt, such as back filling to tidy it up, level it out on the green space side only.

No action resulted in the discussion.

M. Strilchuck MOVED that the board bring Mitchell Brothers to clean up the berm up to a maximum of \$7,000.
